
our supporters and partners, the EPI team has shown what's possible when research, advocacy, and people most impacted by policy come together.

A Look Back

Advocated for 48 bills across 6 key policy areas at the State House



Putting Rhode Islanders First

We had victories with 16 out of the 48 bills on our legislative agenda, from payday lending reform to child care rate increases to solidifying a path for higher minimum wage. EPI also testified against many harmful pieces of legislation, including ones that would cost valuable revenue without providing benefits to most Rhode Islanders. Such proposals included eliminating state taxation of social security income (even for the highest income filers), weakening or eliminating the estate tax, and enacting massive tax credits for data centers. None of these passed.

Legislative Wins

Payday Lending Reform

Closed the 260% APR storefront payday lending loophole to protect households from predatory debt — a major breakthrough years in the making.



Additional Policy Wins

- Paid Family Leave Wage replacement rising to 75% & expanded eligibility
- Baby Bonds Wealth-building opportunity for children in deep poverty
- Minimum Wage Path to \$16/hour in 2026 & \$17/hour in 2027
- Child Care Access Improvements 20% rate increase & extended educator access
- Public Transit & Paratransit \$15M to sustain essential mobility
- Housing Revenue Second luxury home tax to support affordability
- Medicare Savings Program \$7.1M expansion for nursing home staffing & \$12M for wages & retention
- Care Access Reform Pilot limiting prior authorization delays


Revenue for Rhode Islanders Coalition

The Revenue for Rhode Islanders Coalition advocated together to address unmet needs and create a fair tax structure. Our campaign to establish a 3% tax on income above the Top 1% threshold gained serious traction in 2025. EPI, as a leading steering committee member, will continue to advocate to generate more than \$190 million annually for critical housing, education, healthcare, and community needs.

HR-1: Our Federal Fight

H.R.1 (One Big Beautiful Bill Act) represents the greatest threat to Rhode Islanders in a generation. H.R.1. made unprecedented cuts to Medicaid and SNAP to make permanent tax cuts for the wealthy. More than 50,000 Rhode Islanders will lose health insurance and 14,000 Rhode Islanders will be at risk of losing nutrition assistance because of it while also making the state responsible for millions of new costs.

In response, EPI:

- Co-hosted Town Halls with Congressional Delegation to Educate Communities
 About Federal Risks
- Worked with National Partners to Assess State-Level Impacts
- Hosted Several Webinars and Briefings for Communities and Policymakers
- Convened HR-1 Strategy Meetings with Community Leaders and Policy Advocates
- Produced and Widely Circulated a Clear, Accessible HR-1 Infographic
- Participated in EOHHS and DOR Federal Compliance Advisory Groups
- Equipped Advocates, Caseworkers, and Community Organizations with Tools to Protect Families
- Called on State Policymakers to Raise Revenue to Protect Rhode Islanders


